



TERMS AND CONDITIONS / PLEASE READ CAREFULLY:

First: The Customer (Owner/Tenant) agrees to purchase all their propane requirements from Long Energy for a period of one year from the date hereof, and pay for same not later than thirty (30) days from the date of delivery. Minimum 500 gallons for any Propane Protection Plan.

Second: Long Energy agrees, without further cost to the Customer, to tune up the furnace or boiler or A/C unit, depending on plan chosen, test all controls and adjust if necessary; lubricate all bearings and motors; and check all safety controls. It is the responsibility of the Customer to contact Long Energy for an appointment between April 1st and September 1st. The tune up must be done during the contract year.

Third: This contract **does not cover repairs/labor** necessitated by loss or damage due to obsolete or inefficient equipment, frozen or buried propane lines, regulators or tanks, fuel shortages, low draft, damaged chimney, fire, water, wind, hail, lightening, earthquake, theft, vandalism, negligence, riots, strikes, power failure, control safety failure, hard water, snow, or damage resulting from heat failure in a vacant home.

Fourth: The obligation of Long Energy under this agreement shall terminate if the equipment has been altered, tampered with, or repaired by others in a way that, in the opinion of Long Energy, affects the reliability or detracts from the performance of same, or if the heating system has been subjected to misuse through negligence or other causes.

Fifth: Long Energy will not be responsible for any equipment frozen including but not limited to water pipes, baseboard, radiators and customer owned propane regulators and gas lines.

Sixth: The Customer agrees that Long Energy has no liability for soil contamination or any other environmental hazard or violation of whatever nature, to hold harmless and indemnify Long Energy from any liability therefore and from any actions, proceedings, or expenses related thereto. Any excavation and resurfacing costs for all underground tanks

and buried propane lines will be charged to the Customer.

Seventh: This plan is subject to change without notification.

Eighth: This contract will be automatically renewed annually unless terminated by either party in writing.

Ninth: Any parts not listed on this contract are chargeable at prevailing rates (including labor). Buderus and Lennox parts are not covered under these contracts.

Tenth: In the event the Customer fails to pay for said propane within thirty (30) days from date of delivery or ceases to purchase all propane requirements from Long Energy during the one year contract period described herein, then this agreement shall become null and void, and any parts, equipment, or labor furnished to the Customer's heating plan shall then be chargeable to said Customer at prevailing prices.

Eleventh: This contract is for the sole benefit of the Customer and cannot be refunded, assigned or transferred by him/her without the consent of Long Energy.

Twelfth: This contract and any renewal thereof is subject to acceptance and approval of Long Energy.

Thirteenth: Except if you purchase the separate Air Conditioning Contract, this contract covers all service calls related to **Heat Only; Air Conditioner and Plumbing service calls are chargeable (parts and labor).**

Fourteenth: This Contract is not valid until equipment to be covered is inspected by Service Technician.

Fifteenth: Long Energy shall not be responsible for any incidental, consequential, or special damages. In no event shall Long Energy's aggregate liability to Customer or any third party in any matter arising from, relating to or connected with our service or these terms exceed the service plan payments received by the Company in the previous 12 months.

*Any allowance toward replacements of furnaces or boilers must show signs of cracks or leakage.
*Parts that are covered under these plans are clearly identified, PLEASE READ CAREFULLY.

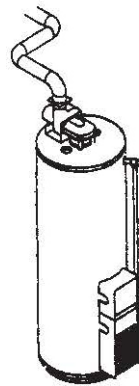

2. Check **Gas Valve** and thermocouple for safe and proper operation.
3. Clean **ignition** and **pilot** assembly for better efficiency and operation.
4. Clean and check **thermostat** and calibration.
5. Clean vent system and monitor **flue** for proper draft conditions.
6. Inspect **chimney base** and clean.
7. Lubricate all blower assemblies, check **blower belts** and **motors** to extend equipment reliability.
8. Inspect **all controls** for proper function, cycling and any dangerous conditions that may exist.
9. Check and replace **air filter**, if necessary, for proper air flow and operation.
10. Check and tighten all **electrical** connections to avoid unnecessary interruptions of heat.

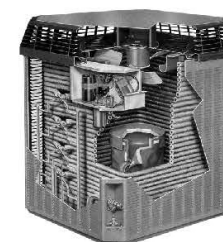

ANY AIR CONDITIONING TUNE-UP AND INSPECTION INCLUDES:

1. Clean and inspect outside **condensing unit** and check for proper operation and air flow. This is the #1 reason for air conditioning compressor failures. Proper care will decrease the operating cost and increase the life of the unit.
2. Check outside condensing **fan blade** for tightness and proper operation.
3. Inspect and clean **condensate drains** and **pumps** to avoid any unnecessary water damage.
4. Check **refrigerant** for proper pressure and possible leaks.
5. Inspect **all controls** for proper function cycling and any dangerous conditions that may exist.
6. Lubricate **blower** assemblies, check **blower belts** and **motors** to extend equipment reliability.
7. Check **amp draw** and **capacitor** for proper operation.
8. Check and replace **air filter**, if necessary, for proper air flow and operation.
9. Clean **evaporator coil** if accessible.
10. Check **superheat/subcooling** charge for proper temperatures.
